ORDINANCE NO. 111522-2

ZONING MAP AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE TALLMADGE CHARTER TOWNSHIP ZONING ORDINANCE BY REZONING CERTAIN LANDS TO THE RP RURAL PRESERVE ZONING DISTRICT, TO PROVIDE FOR SEVERABILITY, TO PROVIDE FOR REPEAL, AND TO ESTABLISH AN EFFECTIVE DATE.

THE CHARTER TOWNSHIP OF TALLMADGE, COUNTY OF OTTAWA, AND STATE OF MICHIGAN, ORDAINS:

Section 1. Amendment. The Zoning Ordinance and Map of the Charter Township of Tallmadge, Ottawa County, Michigan, the map being incorporated by reference in the Zoning Ordinance for the Charter Township of Tallmadge pursuant to Chapter 4, shall be amended so the following lands shall be rezoned to the RP Rural Preserve Zoning District. The lands are in the Charter Township of Tallmadge, Ottawa County, Michigan, and are described as follows:

Part of the Southwest 1/4 of Section 10, Town 7 North, Range 13 West, Tallmadge Township, Ottawa County, Michigan, described as: Commencing at the West 1/4 corner of said Section; thence N89°57'11"E 50.02 feet along the East-West 1/4 line of said Section; thence S01°29'59"E 359.93 feet along the East line of the West 50 feet of the North 1/2 of the Southwest 1/4 of said Section to the Point of Beginning; thence N89°57'11"E 660.00 feet; thence S01°29'59"E 165.00 feet; thence S89°57'11"W 660.00 feet; thence N01°29'59"W 165.00 feet along said East line to the Point of Beginning. Contains 2.50 acres. Subject to easements, restrictions, and rights-of-way of record and;

Part of the Southwest 1/4 of Section 10, Town 7 North, Range 13 West, Tallmadge Township, Ottawa County, Michigan, described as: Commencing at the West 1/4 corner of said Section, thence N89°57'11"E 50.02 feet along the East-West 1/4 line of said Section; thence S01°29'59"E 524.93 feet along the East line of the West 50 feet of the North 1/2 of the Southwest 1/4 of said Section to the Point of Beginning; thence N89°57'11"E 660.00 feet; thence N01°29'59"W 162.00 feet; thence N89°57'11"E 1991.68 feet; thence S01°35'20"E 395.95 feet along the North-South 1/4 line of said Section; thence S89°57'11"W 2652.29 feet along the South line of the North 758.62 feet of the Southwest 1/4 of said Section; thence N01°29'59"W

233.94 feet along said East line to the Point of Beginning. Contains 24.10 acres.  
Subject to easements, restrictions, and rights-of-way of record.

Section 2. Severable Provisions. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.

Section 3. Repeal. All ordinances or parts of ordinances in conflict with this Ordinance are hereby expressly repealed.

Section 4. Effective Date. This amendment to the Tallmadge Charter Township Zoning Ordinance was approved and adopted by the Township Board of Tallmadge Charter Township, Ottawa County, Michigan on December 13, 2022, after a public hearing as required pursuant to Michigan Act 110 of 2006, as amended; after introduction and a first reading on November 15, 2022 and after posting and publication following such first reading as required by Michigan Act 359 of 1947, as amended. This Ordinance shall be effective on December 28, 2022, which date is the eighth day after publication of a Notice of Adoption and Posting of the Zoning Map Amendment Ordinance in the *Grand Rapids Press*, as required by Section 401 of Act 110, as amended. However, this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110, as amended.
