## ORDINANCE NO. 03-12-24-1

## ZONING MAP AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE TALLMADGE CHARTER TOWNSHIP ZONING ORDINANCE BY REZONING CERTAIN LANDS TO THE C-2 GENERAL COMMERCIAL ZONING DISTRICT, TO PROVIDE FOR SEVERABILITY, TO PROVIDE FOR REPEAL, AND TO ESTABLISH AN EFFECTIVE DATE.

THE CHARTER TOWNSHIP OF TALLMADGE, COUNTY OF OTTAWA, AND STATE OF MICHIGAN, ORDAINS:

Section 1. <u>Amendment</u>. The Zoning Ordinance and Map of the Charter Township of Tallmadge, Ottawa County, Michigan, the map being incorporated by reference in the Zoning Ordinance for the Charter Township of Tallmadge pursuant to Chapter 4, shall be amended so the following lands shall be rezoned to the C-2 General Commercial Zoning District. The lands are in the Charter Township of Tallmadge, Ottawa County, Michigan, and are described as follows:

Part of the Northwest 1/4 of Section 26, Town 7 North, Range 13 West, Tallmadge Township, Ottawa County, Michigan, described as: Commencing at the Northwest corner of said Section; thence S02°21'14"E 500.06 feet along the West line of said Section to the Point of Beginning; thence S89°30'10"E 400.00 feet along the South line of the North 500.06 feet of the Northwest 1/4 of said Section; thence N02°20'58"W 446.94 feet along the East line of the West 400 feet of the Northwest 1/4 of said Section; thence S89°30'10"E 703.76 feet; thence S80°31'48"E 126.22 feet; thence S89°30'10"E 129.45 feet, the previous 3 calls being along the South line of M-45 Southerly Right-of-Way; thence S02°10'48"E 1167.54 feet along the East line of the West 1/2 of the Northwest 1/4 of said Section; thence N89°30'10"W 1353.38 feet; thence N02°21'14"W 740.48 feet along the West line of said Section to the Point of Beginning. 70-10-26-100-018 PT

Section 2. <u>Severable Provisions</u>. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.

Section 3. <u>Repeal</u>. All ordinances or parts of ordinances in conflict with this Ordinance are hereby expressly repealed.

Section 4. Effective Date. This amendment to the Tallmadge Charter Township Zoning Ordinance was approved and adopted by the Township Board of Tallmadge Charter Township, Ottawa County, Michigan on March 12, 2024, after a public hearing as required pursuant to Michigan Act 110 of 2006, as amended; after introduction and a first reading on February 13, 2024 and after posting and publication following such first reading as required by Michigan Act 359 of 1947, as amended. This Ordinance shall be effective on April 1, 2024, which date is the eighth day after publication of a Notice of Adoption and Posting of the Zoning Map Amendment Ordinance in the *Grand Rapids Press*, as required by Section 401 of Act 110, as amended. However, this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110, as amended.
