**New Business**

- Public Hearing
  - o Carol Vriesema Zoning Map Amendment application
    - Seeking rezoning 10116 Linden Drive from RP to R-1

Greg Ransford takes the floor to highlight the application. Applicant is looking for a rezone from RP to R-1. This area has been Master planned to R-1 for about 3 decades. Linden is a corridor for various mining sites. This area is lacking some utilities, but does support septic and well. Not considered spot zone due to the size and area uses. Applicant addresses the need for this split.
