The last day to register in any manner other than in-person with the local clerk is:
Monday, October 19, 2026

NOTE: After this date, anyone who qualifies as an elector may register to vote in person with proof of residency
(MCL 168.492) at their local clerk's office at the above posted dates and times.

All city or township clerks' offices will be open
from 7 a.m. to 8 p.m. on Election Day, Tuesday, November 3, 2026 for the purpose of registering voters.
